

# European elections 2024 (EU elections 2024)

**- General – Right to vote in the European elections – Right to vote for non-Austrian EU citizens and Austrians living abroad – Results – Further information**

## General information

Federal Law Gazette II No. 72/2024 published the ordinance of the Federal Government on the invitation to tender for the election of the Austrian Members of the European Parliament. In it, the June 09, 2024 as the election day and March 26, 2024 as the cut-off date. ## Right to vote in the European elections

Persons are eligible to vote in the 2024 European elections if they

- have Austrian citizenship and, if their main place of residence is abroad, have applied for registration in the EU voter register by April 25, 2024 at the latest, or
- have the nationality of another EU member state, provided that they have applied for registration on the EU voter registration list by March 26, 2024 at the latest, and
- are not excluded from the right to vote and
- have reached the age of 16 on election day at the latest (i.e. were born on June 9, 2008 at the latest)

## Right to vote for non-Austrian EU citizens and Austrians living abroad

If non-Austrian citizens of the Union whose main place of residence is in Austria wish to vote for Austrian members of the European Parliament in the 2024 European elections, they must be registered in the European electoral register of the Austrian municipality in which they have their main place of residence. An application for this registration must be submitted by March 26, 2024 at the latest. The form is available in every municipality and can also be downloaded online from the homepage of the Federal Ministry of the Interior ([Link: Information for non-Austrian EU citizens](#)). An entry in the European voter registration remains valid for the duration of the uninterrupted residence in Austria.

Austrians living abroad, on the other hand, must submit an application for registration in the European voter register by April 25, 2024 at the latest in order to obtain the right to vote in the 2024 European elections. The relevant application is available from the respective registration municipality in Austria and can also be downloaded online from the homepage of the Federal Ministry of the Interior ([Link: Information for Austrians living abroad](#)). An entry in the European voter registration is valid for Austrians living abroad for a period of 10 years and must be renewed after 10 years

in order to continue to exercise the right to vote. A new application is possible at any time.
